ORDER:

In the reference 5th cited, the TSTRANSCO has issued orders sanctioning Dearness Allowances to all the Employees/Artisans of TSTRANSCO in the Revised Pay Scales, 2018 and Dearness Relief to the Pensioners/Family Pensioners with effect from 01-01-2020. The TSTRANSCO have also issued orders that the Dearness Allowance Arrears as per the increased rates for the month of January'2020 and February'2020 shall be paid in cash along with salary for the month of March'2020 payable in April'2020 to all the Employees/Artisans of TSTRANSCO and the arrears of Dearness Relief to Pensioners/Family Pensioners as per the increased rates for the month of January'2020 and February'2020 shall be paid in cash along with the Pension/Family Pension for the month of March'2020 payable in April'2020. The Dearness Allowance so calculated shall be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next higher rupee.

2. After careful consideration, the TSSPDCL hereby adopts the orders issued by TSTRANSCO vide its T.O.O.(Jt.Secy-Per)Ms.No.726, dtd:03.03.2020, and accords approval for payment of revised Dearness Allowance to the Employees/Artisans of TSSPDCL in the Revised Pay Scales of 2018 and Dearness Relief to the Pensioners/Family Pensioners of TSSPDCL with effect from 01-01-2020 and shall be made applicable to all Employees/Artisans and Pensioners/Family Pensioners of TSSPDCL as indicated below:

i) Dearness Allowance to the employees:	
D.A. Rates from 01-07-2019	Revised DA rates from 01-01-2020
8.866% of pay	12.886% of pay
(ii) Dearness Relief to Pensioners/Family Pensioners:	
D.R. Rates from 01-07-2019	Revised D.R. Rates from 01-01-2020
8.866% of Pension/ Family pension	12.886% of Pension/ Family pension

- 3. The Dearness Allowance Arrears as per the increased rates for the months of January'2020 and February'2020 shall be paid in cash along with salary for the month of March'2020 payable in April'2020 to all the Employees/Artisans of TSSPDCL and the Arrears of Dearness Relief to Pensioners/Family Pensioners as per the increased rates for the months of January'2020 and February'2020 shall be paid in cash along with the Pension/Family Pension for the month of March'2020 payable in April'2020.
- 4. The Dearness Allowance so calculated shall be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next higher rupee.
