Whereas, in the reference 1<sup>st</sup> & 2<sup>nd</sup> read above, guidelines for absorption of "outsourced personnel" engaged through Contractors/Agencies/Firms for execution of certain works in TSSPDCL; and orders of absorption of 9,459 outsourced personnel out of 10,308 working as on 04-12-2016 & uploaded in the system, into the service of TSSPDCL, were issued.

- 2. Whereas, in the reference 3<sup>rd</sup> read above, the Hon'ble High Court of Judicature at Hyderabad has suspended the orders of absorption of 9,459 outsourced personnel in TSSPDCL, inter-alia, directing that TSSPDCL at its discretion may engage the services of the said "outsourced personnel" on contract basis, on payment of monthly consolidated remuneration, pending disposal of the WP(PIL) No.149/2017 on the file of the Hon'ble High Court of Judicature at Hyderabad.
- 3. Whereas, in the reference 6<sup>th</sup> read above, the orders of absorption of 9,459 outsourced personnel were suspended in compliance with the orders dtd.02-08-2017 of the Hon'ble High Court of Judicature at Hyderabad in WP(PIL) MP.No.261/2017 in WP(PIL) No.149/2017. Consequently, the concerned HODs were permitted to engage the services of 9,456 outsourced personnel whose cases were considered earlier for absorption in the reference 2<sup>nd</sup> read above, temporarily, on contract, on "as is where is basis", on payment of monthly consolidated remuneration.
- 4. Whereas, in the reference 5<sup>th</sup> read above, the Committee scrutinized the Bio-Data particulars of the remaining 849 outsourced personnel whose cases were not considered earlier on various grounds, along with others. The Committee, after scrutiny, recommended the cases of 713 outsourced personnel as indicated below. The Artisans Grades now ordered are subject to change if qualifications are found to be otherwise and shall be brought to the notice of Corporate Office for rectification.

- 5. Whereas, after careful consideration, the concerned SEs/DEs and CGM(HRD) of Corporate Office TSSPDCL are authorized to engage the services of 713 outsourced personnel on contract on "as is where is basis," as mentioned in the Annexure-I appended to this order, with effect from 29-07-2017FN, as an interim arrangement and they shall be informed individually by the respective SEs/DEs that their engagement on contract basis is purely temporary and would not confer any right(s) on them to claim equities, whatsoever, in future. Further, these orders are liable to be withdrawn altogether or altered or modified as deemed fit; and they shall be subject to the outcome of the WP(PIL) No.149/2017 on the file of the Hon'ble High Court of Judicature at Hyderabad.
- 6. The 713 outsourced personnel now being engaged temporarily on contract on "as is where is basis," are entitled for the consolidated remuneration, as indicated below.

- 7. The SEs/DEs and CGM(HRD) of Corporate Office, TSSPDCL are directed not to engage any new outsourced personnel in any of the works, either through Contract Agency / Contractor, hitherto attended by the above outsourced personnel. The remaining outsourced personnel shall be continued as hitherto duly following the existing procedure of their engagement, whose names are mentioned in the Annexure-II.
- 8. Till further orders, the works which were hitherto executed either through Contract Agency / Contractor shall be entrusted to the above outsourced personnel only who are ordered to be engaged on contract. All the contracts entered into thereof shall stand cancelled to that extent with effect from 28-07-2017 AN as ordered in the reference 4th read above.
- 9. The SEs/DEs and CGM(HRD) of Corporate Office, TSSPDCL are requested to take action accordingly and to pay the monthly remuneration as mentioned in Para-6 directly to these 713 outsourced personnel through Bank and to follow the orders scrupulously without any deviation, failing which necessary disciplinary action will be initiated against the concerned, besides recovery of such amounts to the extent of loss sustained by TSSPDCL from the concerned.
- 11. The specimen copy of the order to be issued by the concerned appointing authority to each individual is enclosed herewith.
- 12. These orders are issued with the concurrence of the Director(Finance) vide No. 2192, Dtd.31-08-2017.
