**ORDER:**

Whereas, the Government of Telangana, published the Telangana public Employment (Regulation of Age of Superannuation) Act, 1984 (Telangana Act. 3 of 2021) (Amendment) Act, 2021 in the Telangana Gazette enhancing the Age of Superannuation of all Government employees from 58/60 years to 61 years, in view of the assent of the said Act by the Governor of Telangana on 27.03.2021.

2) Whereas, the Government of Telangana, in exercise of powers, conferred by Sub-section (2) of section 1 of Telangana Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2021, appointed 30<sup>th</sup> day March, 2021 as the date on which the said act shall come into force.

3) Whereas, the Government of Telangana, Finance (HRM.III) Department, further issued orders vide Cir.Memo No. 705517/161/A1/HRM-III/2020, Dt: 04.04.2021, as to the adoption of the Telangana Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2021 (Telangana Act. 3 of 2021), by the other Organisations under the Government with regard to the Enhancing the Age of Superannuation from 58/60 years to 61 years to the employees under their control.

4) Whereas, the Energy Dept. Government of Telangana granted approval vide Letter No Energy-HR/A1/LAQs/7/2021-HR, dated:08.04.2021, to adopted the Telangana Public Employment (Regulation of Age Superannuation) Act, 1984 as amended by Telangana Act. 3 of 2021 enhancing the age of superannuation from 58/60 years to 61 years in respect of all the employees working in TSTRANSCO/TS Power Utilities with effect from 30<sup>th</sup> March, 2021.

5) Whereas, the Telangana Public Employment (Regulation of Age Superannuation) (Amendment) Act, 1984 as amended by Telangana Act. 3 of 2021 is adopted by the TSSPDCL in the references 8<sup>th</sup> & 9<sup>th</sup> read above enhancing the age of superannuation from 58/60 years to 61 years with effect from 30<sup>th</sup> March, 2021.

6) According, the following Amendment is issued to the Standing orders No. 46 of Chapter XIV of the “**Standing Orders, Service Rules and Regulations for Artisans**”.

**CHAPTER XIV – Standing Order No. 46 – Age of Superannuation:**

The age of retirement shall be 58 years i.e., from the Afternoon of the last day of the month in which an Artisan Completes the age of Fifty eight years.

In place of the existing Standing Orders No. 46 as above the following shall be substituted:

**AMENDMENT**

**CHAPTER XIV – Standing Order No. 46 – Age of Superannuation:**

”The age of retirement shall be 61 years i.e., from the Afternoon of the last day of the month in which an Artisan Completes the age of Sixty one years (61).

- 7) The above orders shall come into force with effect from 30.03.2021.
